Procedures that **QUALIFY**

- Arthroscopy
- Cataract Extraction
- Cholecystectomy (Open/Endoscopic)
- Colonoscopy
- Cystoscopy/Cystourethroscopy
- Esophagogastroduodenoscopy (EGD)
- Extracorporeal Shock Wave Lithotripsy (ESWL)
- Transurethral Resection of Prostate (TURP)

ELIGIBILITY

Same as current airfare benefit
(with the exception of qualifying conditions).

- StayWell must be Primary Insurance Carrier.
- Must be a StayWell member for 6 consecutive months.
- Qualifying procedures need to be done and precertified at StayWell's Philippine Centers of Excellence.

Member may avail of either the Travel Allowance **OR** Airfare Benefit if they qualify for both within the same policy year.

In the event that a member will be traveling to the Philippines Center of Excellence for two (2) different qualifying conditions (i.e. heart surgery and colonoscopy), only one (1) benefit (either airfare or travel allowance) will be paid.

How do I get my **REIMBURSEMENT?**

All official receipts and documents
must have claimant's name and

**MUST BE SUBMITTED WITHIN 30 DAYS
OF DATE OF RETURN TO GUAM.**

Reimbursement upon submission of original official receipts.

These receipts and documents include:

- **Airfare Receipt**
Lowest economy-class, direct roundtrip to Center of Excellence in the Philippines from Guam.
- **Airline Boarding Passes**
Screenshots of electronic boarding passes are acceptable, provided they clearly show the actual flight date for both the outbound and return flights to and from the (COE) Center of Excellence in the Philippines.
- **Official Hotel Receipt**
- **Operative report and/or Medical Certificate**

Reimbursement up to **\$500** for airfare/lodging

- No reimbursement will be made for use of airline mileage and/or for complimentary lodging.
- Reimbursement for lodging up to 5 days maximum; must be availed around the actual date of service for the qualifying procedure.
- Reimbursement for travel allowance will follow existing PTC reimbursement process.
