REVISED TRAVEL GUIDELINES AND RESTRICTIONS

Relative to Memorandum from the Executive Secretary dated 10 September 2021 re: *Imposition of Travel Restrictions on Countries under the Red List*, IATF Resolution Nos. 114, 128-A, 136 and 136-B, please be advised of the summary of travel guidelines and restrictions:

I. SUMMARY OF RED LIST COUNTRIES¹ (Effective September 12 to 18, 2021)

1. ALL arriving passengers coming from, or who have been to the above Red List Countries within the last fourteen (14) days shall **NOT be allowed entry²**;
2. ALL arriving passengers coming from, or who have been to the above Red List Countries within the last fourteen (14) days, **arriving before 1200H of 12 September 2021**, shall undergo a fourteen (14)-day quarantine period³ and be required a Reverse Transcription-Polymerase Chain Reaction (RT-PCR) test on the seventh day, with day one being the day of arrival;
3. Those who: **(a) transited or who have a mere lay-over at the airport of Red List Countries** (lay-over only at the airport and with no immigration admission at said countries); and **(b) NOT coming from these countries** may be allowed entry, PROVIDED they are authorized to enter the country thru relevant resolutions of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID) and subjected to existing testing and quarantine protocols issued by the Department of Health (DOH).

All arriving passengers allowed to enter through previous IATF Resolutions and are coming from the Green List Countries shall be allowed entry subject to the health and quarantine protocols prescribed by the DOH Guidelines on quarantine and testing protocols.

III. YELLOW LIST COUNTRIES

Yellow list countries are those countries not in the Red List nor in the Green List.

All arriving passengers allowed to enter through previous IATF Resolutions coming from the Yellow List Countries shall be allowed entry subject to the health and quarantine protocols prescribed by the DOH Guidelines on quarantine and testing protocols.

Existing guidelines for arriving Section 9(e) visa holders and crew member/s shall still be observed.

The foregoing is without prejudice to the exercise of the mandate of the Bureau of Immigration in Arrival and Departure formalities.
